KRÄUTER GROZ has been organically certified for over 20 years and is inspected at regular intervals by the inspection body DE-ÖKO-039 | GfRS GmbH, Göttingen.

The organic seal identifies products and raw materials from controlled organic cultivation. Organic products are becoming more and more important from year to year: Our range grows with new organic items every year, whereby we always keep sustainability in mind. The focus is on avoiding pesticides and environmentally friendly cultivation.
